CATEGORY PERFORMANCE (R12 June 2025):

Table Wine - Chile within MBLL represents a \$9.1 million annual portfolio, generating a dollar growth rate of +3.2%, and a litre growth rate of +0.8%.

- ✓ Red Wine represents 65% of the category sales, with a \$ growth rate of +1.8%
- ✓ White Wine represents 32% of category sales, with \$ growth rate of +4.1%
- ✓ Rose Wine represents 2% of the category sales, with a \$ growth rate of +40.1%, growth with new additions to the segment
- ✓ 750ml format is dominant size representing 55% of category sales, with a \$ growth rate of +2.1%
- ✓ In the 750ml format, wines priced under \$25.00 represent 93% of segment sales with a \$ growth rate of +1.3%

- ✓ Product must be CFIA (Canadian Food Inspection Agency) compliant

Additional requirements if applicable:

- ✓ Declaration of Origin (Imported products)
- ✓ Annual Declaration of Production (new suppliers claiming Micro status)
- ✓ Product Sell Sheet (Optional)
