General Notes

Canada Wide - 20 May 2026 - For any inland collections or deliveries to Louisville Rail ramp, be prepared for significant delays between June and July this year. Highway I-65 will be closed for two months to replace three key bridges and all traffic will be detoured to other highways.

Middle East - 2 April 2026 – Middle East Situation Updates

Port Status

Operational :

UAE (excluding Khor Fakkan restrictions); Saudi ports; Umm Qasr (Iraq); Hamad (Qatar); Oman – Sohar, Duqm; Beirut (Lebanon); Aqaba (Jordan)

Partially Operational:

Kuwait – Shuwaikh and Shuaiba; Bahrain; Oman – Salalah

Restricted / Disrupted:

Khor Fakkan (UAE) – Not accepting any export containers (empties or laden) due to terminal capacity constraints. Congestion is building, with waiting times potentially reaching 7–10 days.

Middle East - 2 April 2026 - Additional Notes (Con't)

Khor Fakkan (UAE)

- Export containers (empty and laden) not accepted due to capacity limitations
- GulfTainer applies an Emergency Operational Recovery Surcharge effective 15 March
- Surcharge applies to container handling at Khor Fakkan Commercial Terminal (KCT)
- Containers arriving via Khor Fakkan POD can be redirected to Sajaa or Mileeha ICDs to reduce truck congestion

Fujairah (UAE)

- Only the container terminal is operational

Oman – Sohar

- Laden containers can only be gated in 5 days prior to vessel ETA
- IMDG, OOG and BBK shipments require prior approval for both import and export
- No pre-cooling or container washing services available
- Maximum container moves per vessel limited to 3,000 TEUs

Oman – Duqm

- Operational, but DG shipments are not permitted

Carrier Status & Service Disruptions

Across all major liners:

- Full suspension of bookings to and from Arabian Gulf ports; carriers have stopped accepting services via the Strait of Hormuz
- Service omissions, early voyage terminations, diversions, and rerouting via the Cape of Good Hope are widely in effect
- Restrictions on reefer, DG, and special containers are now applied across the industry

Asia - 25 March 2026 - Middle East disruptions have triggered widespread service cancellations and rerouting across major carriers. Significant volumes originally bound for the Persian Gulf are now being diverted to Singapore and the southern Malaysia hubs, resulting in pronounced vessel bunching and elevated operational pressure.

Singapore and Tanjung Pelepas are both operating near full yard capacity, with berthing delays of 5–7 days and rising transshipment dwell times. Spillover congestion has also reached Port Klang, where concentrated arrivals and schedule reshuffling are affecting transshipment connectivity.

Customers using Singapore / Tanjung Pelepas / Port Klang for transshipment are advised to plan an additional 3–7 days of buffer time, assess flexible routing options, and monitor shipment status closely through the myHillebrandGori platform.

Western Canada

No major misses at this time

19 April 2026 - Please be advised that we are currently responding to a disruption we had yesterday on the mainline near Seddall, British Columbia (approximately 250 km east of Vancouver).

Vancouver - 5 June 2026 - No vessel berthing delays reported, yard utilization at 81%. Average import rail dwell time is 3.1 days.

Eastern Canada

No major misses at this time

St. John - 13 Jan 2026 - Vessels continue to face schedule delays and terminal utilization reduced to 31% at DPW Saint John. Average import dwell time 4.1

14 April 2026 - Derailment occurred near Arms, Ontario **CN is reviewing the situation and working with CP to limit the delays.

Montreal - 5 June 2026 - No vessel berthing delays reported, terminal yard utilization at 71%. Import rail dwell time 4.8 days.

California/US

Currently no issues in California or Shipping from the USA to Manitoba

19 Jun 2025 - The Government of Manitoba has no update on removing US product embargo.

Argentina / Chile

Argentina - 9 June 2026 - The international road connecting Mendoza to Chilean ports has been CLOSED due to winter weather. Note from May to September, wine shipments routed through Chilean ports (Valparaiso or San Antonio) can face delays. Heavy snowfall along the Andes pass often disrupts the crossing between Argentina and Chile.

Chile - 5 June 2026 - Vessel wait time of 4 hours with port congestion at DPW Terminal. San Antonio Terminal 2 hours waiting time, yard at 45% utilization.

Chile - 15 June 2026 - A nationwide port strike for Chilean ports is expected to start on June 18, 2026, pending official confirmation. If the strike proceeds, this could delay vessel and terminal operations at Chilean ports and also impact goods in transit from Argentina loading at Chilean ports. We will continue to update as more information becomes available.

Australia

Australia port services are normal. No major delay at source.

New Zealand

New Zealand port services are normal. No major delay at source.

Europe

Belgium - 13 March 2026 - Unplanned industrial action over government pension reform disrupted Belgium ports this week. This affected multiple components of port operations, creating a considerable vessel cargo backlog and terminal disruption. Plan for delays and schedule changes as a result.

Belgium - 12 May 2026 - A general strike on May 12, 2026 affected Belgium public transport sectors. Minimal impact to operations at Port of Antwerp

France - 13 March 2026 - Plan for additional lead times for shipments moving via Le Havre, worsened by the recent industrial action at Belgian ports this week. Carriers have announced vessel changes or blank sailings, especially impacting trade routes for North American destinations.

France - 25 March 2026 - All terminals and depots in Le Havre are closed due to strong winds.

France - 26 March 2026 - All terminals and depots in Fos-sur-Mer are closed due to strong winds.

France - 19 May 2026 - All French ports will be on a 24-hour strike on May 29

Italy - 18 May 2026 - A 24 hour general strike was announced from 21:00 hours on Sunday May 17 through 21:00 hours on Monday May 18, 2026, affecting public transport systems. Air freight schedules are excluded from the strike and minimal impact is expected for container operations.

Russian Sanctions still in place for exporting from Russia

Ukraine is still under an act of war declaration so shipping from Ukraine to Canada is on hold

South Africa

18 February 2026 - Operations at Cape Town terminals face ongoing disruptions due to high wind gusts. Current delays are averaging 6 days or longer. Seasonal strong winds expected through the end of February.

14 May 2026 - Severe weather has disrupted inland transport across the Western Cape region over the past few weeks. Flooding and road infrastructure damage has resulted in delays in order collection, container positioning and deliveries. Reach out to your Hillebrand Gori team for more information on pending shipments, alternative routing and lead times. Operations at Cape Town are facing intermittent closures due to high wind gusts.
